## **EDUCATIONAL SESSION**

## Home Health/Hospice

Maureen Hurley, RN, CHPN provided education on Home Health/Hospice. Dr. Bernadette Meade, Hospice Medical Director, came to Campbell County several years ago with many years of geriatric and hospice experience. In 2003 Hospice became a department of CCMH, under the same leadership and staff as Home Health. In 2010 Close to Home Hospice and Hospitality House opened. There are currently 34 staff including RNs, CNAs, PTs, MSWs, billing and clerical to cover 24/7 inpatient and home based hospice patients, bereavement program, and home health, including administration and Lifeline program. "Hospice care is an approach to treatment that recognizes that the impending death of an individual warrants a change in the focus from curative care to palliative care for relief of pain and for symptom management". Individuals who qualify for hospice care must have a prognosis of 6 months or less if the terminal condition runs its expected course, based on the primary diagnosis and comorbidities' that may influence the prognosis. The patient's attending physician and Hospice Medical Director must both certify the anticipated prognosis. Levels of care include routine home care. respite care, general inpatient care and continuous home care. Generous donations from the community assist in supporting bereavement services for family up to 13 months after a death. Hospice care is an option that can be offered to patients with end-stage/terminal illness.

#### **CCHCF By-laws**

Mr. Fitzgerald explained that the Healthcare Foundation by-laws will have one additional amendment to recommend at the next Board meeting.

# Mr. Dunlap moved, seconded by Dr. Mitchell, to table voting on the by-law revisions until the next Board meeting.

## Wright Advisory Board Trustees

Mr. Hite read a letter from the Wright Advisory Board recommending Brandi Harlow, Karl Bertagnole and Mandy Quarters be approved by the CCH Board of Trustees to serve on the Wright Advisory Board each for a three year term.

Dr. Mitchell moved, seconded by Mr. Dunlap, to approve recommendation from the Wright Advisory Board to appoint Brandi Harlow, Karl Bertognole and Mandy Quarters to serve on the Wright Advisory Board, each for a three year term. Mr. Hite, Mr. Dugan, Mr. Todd, Dr. Mitchell, Mr. Dunlap and Mr. Jackson voted aye. Motion carried.

## Construction Method for Parking Garage

Mr. Crichton explained that the Facilities Committee discussed the benefits of a CMAR delivery option for the parking garage, but did not properly vote to bring the motion to the meeting tonight. Mr. Fitzgerald clarified the recommendation to come before the Board tonight is for the construction method and not the person.

Mr. Dugan moved, seconded by Dr. Mitchell, that Campbell County Health adopt a Construction Manager at Risk construction method for the parking garage project as recommended by the Facilities Committee.

Mr. Dunlap stated he has seen construction manager at risk projects cost millions of additional dollars. He suggested having all the plans drawn up and let companies bid on the project. With construction manager at risk we pay a company 4-6% more and we need to be fiscally responsible.

# Mr. Dunlap moved to table the motion until the Board has a chance to talk about the project and obtain additional information.

Mr. Crichton explained that the Legacy project was started as a design build project not as a construction manager at risk project. In a design build project the architect is responsible and under contract to the contractor. The project is designed as it is being built. A construction manager at risk project brings a contractor onboard as a partner for a fixed fee for a period of time prior to bids actually going out for a project. When a project goes out for bid on a CMAR agreement those construction documents are 100% complete as far as the architect is concerned and have been reviewed by the construction manager. It allows us to get a contractor onboard with the architect under contract to the hospital rather than one under contract to the other and we are able to manage both of those contractual relationships. Mr. Crichton suggests that we get a recommendation back to the Board of Trustees for a budget approval based on the construction manager's review of the architect engineer drawings which would typically be 95%. The construction manager would solicit for sub-contractor bids for each phase of work to be completed. Those bids then become the guaranteed maximum price that is



entered into that agreement. Dr. Mitchell suggested that if this item is tabled it be brought back to the Board for a vote next Tuesday at the public Board retreat. Mr. Todd stated that the Facilities committee voted on the CMAR and the purpose of the committee is to bring a recommendation to the full Board and to trust the committee to select the right process. Mr. Jackson stated that he thought the changes that needed to be made are CCH's organizational process which are now in place.

There is no second to the recommendation to table.

Mr. Hite called for the vote on the motion that Campbell County Health adopt a Construction Manager at Risk construction method for the parking garage project as recommended by the Facilities Committee. Mr. Hite, Mr. Dugan, Mr. Todd, Dr. Mitchell and Mr. Jackson voted aye. Mr. Dunlap opposed. Motion carried.

## Healthcare Foundation

Mr. Jackson reported the Healthcare Foundation met on September 28th. The Black Cat Ball estimated gross revenue was \$156,000. The VIP project had close to 2000 children with returned vaccine forms. The Healthcare Foundation will start the initial planning of a capital campaign to raise money for the PET CT scan project.

## Legacy Advisory Board

Mr. Todd reported the Legacy Advisory board met on October 12<sup>th.</sup> Bruce Roosa is working with CCH and Pioneer Manor to create a caregiver support group which will begin in January. An ice cream machine will be purchased in the near future to replace the machine that has broken.

## **BHS Advisory Board**

Mr. Todd reported the Behavioral Health Advisory Board met on October 15<sup>th</sup>. The Board toured the new unit which will be a huge benefit to the community. The 3rd quarter census was 4,959 patient contacts. Kip Farnum and Jeff Rice are working on holding seminars and conferences for parents and trying to get parents involved with topics such as suicide prevention, and what to look for in your child.

#### Financial Report

Mr. Andy Fitzgerald reported the following:

- CCMH's average daily census was 24 versus a budget of 28.
- Pioneer Manor's average daily census was 115 versus a budget of 113 in September.
- Outpatient visits were 497 under budget.
- Clinic visits were 1,562 under budget and increased 236 visits compared to September 2014.
- ER visits were 15 under budget.
- WIC visits were 439 under budget.
- Net patient revenue was \$1,862k under budget.
- Operating expenses were under budget \$926k in September.
- Salaries and benefits were under budget \$904k as a result of FTEs under budget by 48.
   Supplies increased as a result of Pharmacy drug costs. Contract services were over budget due to contract staffing at Pioneer Manor, Med Surg, OB & Nursery. Other expenses decreased due to a general decrease of expenditures in this category.
- EBIDA was under budget \$918k in September.
- September's operating loss was \$1,491k vs. a budgeted loss of \$564k.
- Net gain was \$12k in September vs. a budgeted gain of \$952k.

## **Patient Services**

Ms. Deb Tonn reported that an out of state patient's puppy was rescued this week, thanks to Plant Ops, which was the best medicine for the patient. The inpatient psychiatric unit has been opened which will include the ability to admit adolescents. There is an 8 bed capacity which allow for either four adolescents and four adults or 6 and 2 depending on the need. The two populations do not co-habitat and are in their own separate space. The Meditech go live is scheduled for December 1st thanks to our clinical and IT staff as well as a consultant helping to make sure that all goes well.

#### **Human Resources**

Mr. John Fitch provided information on subrogation which is financial reimbursement from the responsible party for a claim paid by itself. Generally, this occurs as a result of an accident where another party is responsible for the accident. Medical bills are sent to our 3<sup>rd</sup> party insurance provider, BC/BS of Wyoming, for payment. Since CCH is self-insured, CCH pays the claims up to \$100,000. If claims exceed this amount, claims are paid by our Stop Loss carrier. If the employee seeks a financial settlement as a result of the accident and is successful, BC/BS will then seek subrogation from the employee for repayment of the medical claims paid by CCH. Subrogation cases occur approximately once or twice annually.



## **Physician Services**

Mr. Bill Stangl reported the clinics continue to work on an improvement plan and are focusing on CGcaps scores especially in the front desk area and patient communications. The PLC has a mini retreat scheduled in November. Medical Management planning review will be held in January.
