Mr. Jackson called the meeting to order at 12:17 p.m. Minutes of the July 1, 2014 Physician Retention and Recruitment Committee meeting were reviewed and approved.

### RECRUITMENT

#### Dermatology

Mr. Fitzgerald and Ms. Viergets have met with a Dermatologist from Casper who currently holds clinic hours in Gillette as well. He and his partner would like to expand their Gillette practice to 3-4 days per week, based on volume and demand. Both providers are Board Certified and perform MOHS surgery. Mr. Fitzgerald asked if this would this satisfy CCMH's recruitment need for Dermatology. Several questions were asked, such as would these providers see Residents at Pioneer Manor and do they accept Medicaid and Medicare patients. It was noted that Administration is still in contact with the Dermatologist who visited recently and are trying to schedule a second site visit. This topic will be discussed at this month's Board meeting. In the meantime, recruitment efforts for Dermatology will continue.

### Endocrinology - Update

Ms. Viergets has been in communication with a Salt Lake City provider who provides coverage in Casper, and was interested in spending a couple days per month in Gillette. CCMH has partnered with Wyoming Medical Center on recruitment efforts for Endocrinology, and they may have a viable candidate who would be in Casper full time.

### Radiology

A WWAMI participant, who will be finishing a Fellowship program next Summer, is scheduled for a site visit August 25 and 26. The same recruitment package will be offered to this candidate, who is from the community and has expressed the desire to practice in Gillette.

A site visit is scheduled for August 13-15 for a Florida MD who has inquired on CCMH's opportunity.

### Physician Extenders

A contract is being finalized for a midlevel who interviewed to practice at The Kids Clinic.

Site visits are being scheduled for several Physician Assistants for the Walk in Clinic, two for replacements and one additional.

#### WWAMI

Dr. Kirven will be onsite August 6 to talk with departments interested in hosting Clerkship rotations.

#### Internal Medicine Residency Program

Dr. Stamato reported that he received an email from Billings Clinic regarding the implementation of an Internal Medicine Residency Program, and noted that this could be a good opportunity for CCMH's recruitment efforts. Discussion ensued on what steps should be taken after the program has been established.
