Recruitment Guidelines

- Revised Recruitment Guidelines for final review the board had approved the recommendation to increase student or home loan recruitment incentive to \$100k to \$130k for critical recruits. The stipend would be up to \$15k (at administration's discretion) for a resident or fellows on a critical needs position making this an incentive.
