2. RECRUITMENT

OLD BUSINESS:

<u>Medical Staff Recruitment Referral Incentive Policy</u> – This policy was discussed, at the July 21st Board Meeting, as a reminder of incentives that are available to any person in the community, with the exception of Hospital Administration and Board Members.

Incentive #1: If Provider is MD/DO then incentive amount is \$5000 with \$2500 paid to referring individual when provider begins at CCH, and the remaining \$2500 paid to referring individual after provider has been with CCH for one year.

Incentive #2: If Provider is a mid-level, then the incentive amount is \$2500 split in to (2) increments of \$1250, paid the same as the physicians incentive.

<u>Recruitment Guidelines</u> – The Recruitment Guidelines were discussed at the July 21st Board Meeting to confirm that CCH Administration is given permission to use own judgment with regards to extending offer letter or preliminary contract to a visiting provider *prior* to that provider leaving the facilities.

NEW BUSINESS:

Recruitment Update

o ECD:

- The candidate that visited in April is scheduled for a few "shadowing" shifts in September. Candidate is in the credentialing process.
- The MI candidate is to make a decision by the end of August.
- Candidate from IL is interested. Medical Directors and Administration to meet on 8/3 to discuss extending an offer.

- o Physician Extenders:
 - Family Practice: PA to start in outpatient clinic 10/10.
 - Ortho: (2) PAs to begin 8/29; one in Ortho and one at PROS.

o Behavioral Health:

- TX Psychiatrist candidate site visit scheduled for August 12
- Ontario candidate (5/13) is considering but decision delayed due to family member death.
- o **Rheumatology**: site visit was 8/2; positive visit; spouse is pediatrician.
- o **Pulmonology:** We tentatively have (2) locums starting next month, each providing week on/week off coverage.
- o **Sleep Lab:** We have a provider that will be here 1 day/week to cover Sleep Lab and follow-up of sleep studies. Will also be available remotely as needed.

<u>Demand Tool</u> - There are no changes since last month. Next update is scheduled for 2017.

<u>WWAMI site Visit</u> - There is a site visit scheduled for August 18th for Dr. Larry Kirven and (2) University of Washington faculty members. The purpose of this visit is to tour our facilities and student housing and to meet all individuals involved with the WWAMI Clerkship program for Campbell County Health. Our initial application was approved and this visit will give us the final approval.
